Description

MarClean MB40 is a phosphoric acid NLS cargo tank cleaner with wetting agents. MarClean MB40 is designed to remove white residues from fatty acids and caustic soda in cargo tanks. MarClean MB40 works well against lime and cement residues in cargo holds. MarClean MB40 brightens up aluminium, copper and stainless steel.

Directions for Use

Re-circulation Method. Mix a solution of 0.5-5% MarClean MB40 in fresh water. Then re-circulate the mixed solution in the tanks to be cleaned. Let the solution re-circulate for approximately 2 to 6 hours. One mixed solution is normally sufficient to clean up to 3 to 4 tanks. After letting the solution re-circulate for the advised time, please rinse the tank with plenty of seawater or freshwater. Let it dry, and the cargo tank is ready to carry its next required cargo.

Spray Method. Mix a solution of 30-50 % MarClean MB40 in fresh water. Then spray the solution on the contaminated areas. Do not allow the mixed solution to dry on the sprayed surface, this will cause problems. Now, after the solution has done its work to the surface, please rinse the tank with seawater or freshwater. There might be a possibility to steam the tank if necessary.

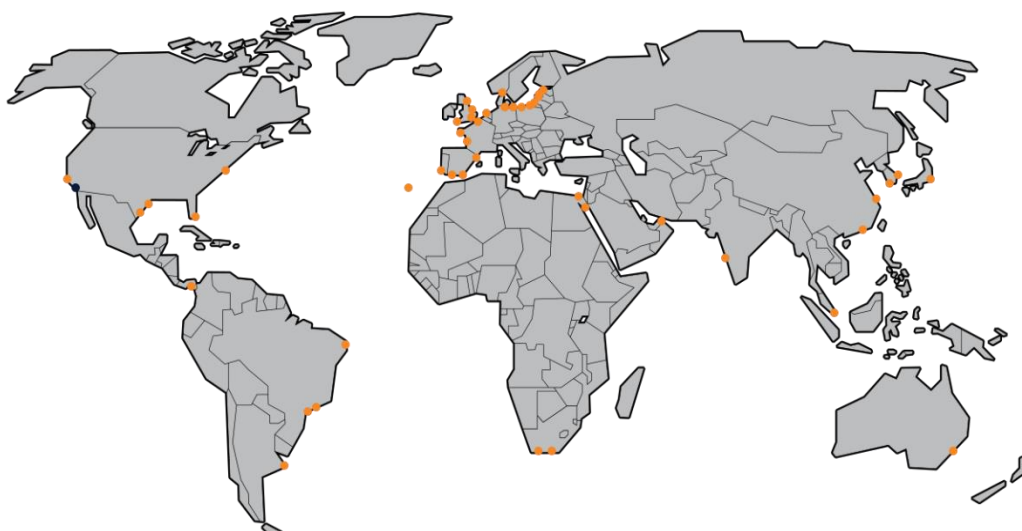
